## Cal Poly Humboldt Employee Reporting Obligations

The California State University system issued the Nondiscrimination Policy to comply with Title IX (of the Education Amendments of 1972, US Department of Education). This policy classifies almost every faculty and staff member on campus as having the "duty to report". Any Employee who knows or has reason to know of incidents that may violate the Nondiscrimination Policy has a duty to promptly report to the Title IX Coordinator/Discrimination, Harassment, Retaliation ("DHR") Administrator, who are the campus officials designated to receive these reports. Employees are required to disclose all information available, including the names of the Parties involved, even where the person has requested anonymity.

## What this means for staff and faculty:

If a student tells you about an incident of sexual harassment or sexual violence and they provide information that this harm occurred while they were enrolled at Cal Poly Humboldt, you are required to fill out the following online report: https://link.humboldt.edu/TitleIXReport.

The Title IX Coordinator or their designee will then contact the student to offer options for support, accommodations and accountability.

Students may speak and write about their experiences with sexual harassment and sexual violence in papers, classes, and in discussions with faculty and staff, and no report needs to be made unless students specify that the violence happened while they were a student at Cal Poly Humboldt.

Cal Poly Humboldt's goal in implementing the CSU Nondiscrimination Policy is to link survivors of sexual violence with support and to hold accountable those who choose to harm others.
